NOTIFICATION

In exercise of the powers conferred by Section –99 of the Andhra Pradesh Education (Act. 1 of 1982) the Governor of Andhra Pradesh hereby makes the following addendum to the Andhra Pradesh General Nurse Training Institutions (Admission into General Nursing Training and grant of permission to Private Schools of Nursing) Rules, 1997 issued in G.O.Ms.No.313, Health, Medical and Family Welfare (M2) Department, Dt. 16-8-1997.

ADDENDUM

After the words “ per head per annum” occurring in Rule-11(i) of the rules issued in G.O.Ms.No.1 313, Health, Medical and family Welfare (M2) Department, Dt. 16-8-1997 the following shall be added:-

“ Nursing Schools which have their own Hospitals and impart Training to their Student Nurses in their Hospitals and require clinical attachment of Government Hospitals in the faculties which they do not have in their own hospitals for purposes of imparting training for short periods i.e., 3 months or less shall pay clinical attachment fee of Rs. 250/- per head”.
