ORDER:

In the G.Os 1st to 3rd read above, orders were issued notifying, among other things, fixation of Fee to General Nursing and Midwifery courses, MPHWF) , DMLT and other Paramedical courses.

2. In the letter 4th read above, the Member-Secretary, Admission & Fee Regulatory Committee for matters relating to Fixation of Fee Structures for Private Un-aided Professional Institutions in the State of Andhra Pradesh has fixed the Fee Structures for (I) General Nursing & Midwifery (GNM) course, (II) Multi Purpose Health Workers (F) (MPHW (F) course, and (III) Diploma in Medical Lab Technology (DMLT) & other Para-Medical Diploma and Certificate Courses in Private Unaided Nursing & Para-Medical Institutions on 2-9-2010 for the academic years 2010-11, 2011-12 and 2012-13 and furnished the information to Government.

3. After careful examination of the proposals of the Admission and Fee Regulatory Committee on the fee structure for General Nursing and Midwifery courses, MPHWF) , DMLT and other Paramedical courses, Government have decided to accept the Fee fixation proposals of the Admission and Fee Regulatory Committee and accordingly hereby order the following fee structure for General Nursing and Midwifery courses, MPHWF) , DMLT and other Paramedical courses in private un-aided Nursing and Para-Medical Institutions in the state for the Academic years 2008-2009, 2009-2010 and 2010-2011.

1. FOR GENERAL NURSING & MIDWIFERY (GNM) COURSE:

a) The tuition fee is fixed

---at Rs.14,000/- (Rupees Fourteen thousands only) per annum
for each student for 40% Government quota seats, and

---upto Rs.65,000/- (Rupees Sixty five thousands only) per annum
for each student for 60% Management seats.

b) To fix a fee of Rs.250/- (Rupees Two hundred and fifty only) per
subject as referred fee (for failed students)

c) To fix the special fee for each student for both Govt. quota seats
and Management seats as follows:

1. Admission fee	Rs.500/- per annum
2. Caution money deposit (refundable)	Rs.1,500/- (as one time payment)
3. Special fees (Extra curricular, sports, Games, function etc)	Rs. 1,500/- per annum
4. Uniform fee	Rs.2,500/- per annum
5. Transportation	Rs.3,600/- per annum (Rs.300/-P.M)
6. Library fee:	Rs.900/- per annum
7. Laboratory fee	Rs,2,500/- per annum

2. FOR MULTIPURPOSE HEALTH WORKERS (F) (MPHW(F) COURSE:

a) The tuition fee is fixed

---at Rs.7,500/- (Rupees Seven thousand five hundred only) per annum for each student for 40% Government quota seats, and

---upto Rs.33,000/- (Rupees Thirty three thousands only) per annum for each student for 60% Management seats.

b) To fix a fee of Rs.250/- (Rupees Two hundred and fifty only) per subject as referred fee (for failed students)

3. FOR DIPLOMA IN MEDICAL LAB. TECHNOLOGY (DMLT) & OTHER PARA MEDICAL DIPLOMA AND CERTIFICATE COURSES:

a) a) The tuition fee is fixed

---at Rs.13,000/- (Rupees Thirteen thousands only) per annum for each student for 40% Government quota seats, and

---upto Rs.40,000/- (Rupees forty thousands only) per annum for each student for 60% Management seats.

b) To fix a fee of Rs.250/- (Rupees Two hundred and fifty only) per subject as referred fee (for failed students)

c) To fix the special fee for each student for both Govt. quota seats and Management seats as follows:-

1. Admission fee	Rs.500/- per annum
2. Caution money deposit (refundable)	Rs.1,500/- (as one time payment)
3. Special fees (Extra curricular, sports, Games, function etc)	Rs. 1,500/- per annum
4. Library fee	Rs.500/- per annum
5. 5. Laboratory fee	Rs,2,500/- per annum

The Member-Secretary, Admission & Fee Regulatory Committee has also issued the following directions to the Private Nursing & Para-Medical Colleges concerned in the proceedings issued by the Committee relating to the fixation of fee structure for the above said Under-graduate & Para-Medical Courses:

i) The Management shall not charge any capitation Fee and there shall not be any Profiteering. Except the above Fee fixed by the Committee, no other amount, either directly or indirectly can be charged un-authorizedly or illegally by the Management. If any such other amount is charged under any other head or guise (e.g. donation etc.) it

would amount to charging of Capitation Fee. The surplus (Profit) that is generated from the collection of the Fee must be for the benefit of the institution and cannot be diverted for other purposes or for personal gain.

- ii) The students admitted to the course during the academic years 2010-11, 2011-12 and 2012-13 shall pay every year the same fee as paid during the first year of their admission till they complete the course.
- iii) The students who were admitted to the course prior to the academic year 2010-11 shall continue to pay every year the same annual fee at the rate existing at the time of their admission till they complete the courses.
- iv) The institutions shall collect the Fee in advance only for the particular year either in lumpsum or in equal monthly installments.
- v) The fixation of the Fee structure by the Committee will not by itself enable or permit the managements to run the relevant courses in their institutions, if they are otherwise not duly recognized and permitted by the Government/NCI/Ap.Nurses & Midwives Council/A.P.Para Medical Board/concerned University at any relevant time.
- vi) As contemplated in Rule 4(V) of the AFRC. Rules issued in G.O.Ms.No.6, H.E.(EC.2) Deptt., dt. 8/1/2007, the Govt. has to notify the Fee Structure determined by the A.F.R.C.

The Director of Medical Education / Registrar, Dr.NTR University of Health Sciences, Vijayawada/ Secretary, A.P.Para Medical Board shall take necessary action in the matter accordingly.
