CIRCULAR

Sub: TGNMC – Indian Nursing Council(INC) – Granting of Mercy Chance – Relaxing of maximum time period (double the duration of the course) - Conducting of Basic Examination by the TGNMC in the respective Nursing course(s) GNM, BSc (N), Post-basic B.Sc. (N) -- Reg.

- 3. From the Secretary, Indian Nursing Council, New Delhi Notification No.1 of 2023 F. No. 1-6/LT/2023-INC, dated 19-01-2023.

With reference to the subject cited above, the Indian Nursing Council, New Delhi in the reference 1st cited, has resolved the following Resolution regarding granting of mercy chance/ relaxation of maximum time period to the students who have completed the theory and clinicals for the course(s) of GNM / BSc(N), Post-basic B.Sc.(N) and M.Sc. (N) and have backlogs/failed/not attempted the final examinations: -

"Maximum time limit for completing Nursing course can be relaxed subject to the condition that, such candidate qualify a basic examination conducted (for the purpose) by the respective State Nursing Council in order to be allowed to continue the course/appear in the University examination".

- 2. It is clarified that "Mercy change is not applicable to candidates who discontinue or re-join the Course" and issued "Examination Guidelines" vide References 2nd and 3rd cited, respectively.
- 3. In the above context, as per the directions of Indian Nursing Council, it has been considered that the cases of those candidates who have completed the Nursing Programme/ Course (Theory and Practical) in the prescribed maximum time limit (double the duration of the Program / Course) and the candidate was not able to clear the final year examination of the respective program / course within the prescribed maximum duration. Therefore, the Telangana Nurses and Midwives Council (TGNMC) has decided to conduct a written examination to the candidates who were not able to clear the final year examination of the respective programme / course within the prescribed maximum period of duration, under mercy chance.
- 4. The TGNMC would like to draw the attention of all the Principals of Nursing Colleges and Schools of Nursing under Government sector / Private sector in the Telangana State are requested to take necessary action in this regard and intimate to the candidate and relevant stake holders who are interested to appear the mercy examination to be conducted by the Telangana Nurses and Midwives Council (TGNMC), in due course.
- 5. Hence, all the nursing students who intend / desires to attend the Mercy chance examination, has to paid an amount of Rs.500/- (Rupees five hundred only) on-line in Council web site "hmis.telangana.gov.in-Attestation", and directed to submit their application form duly filled in, through the Principal concerned who studied in the Institution / College, to this Council either by Post / Courier or physically along with payment receipt, on or before 21-10-2024.

- The eligibility criteria for appearing for the mercy chance examination are as follows:
 - i. Mercy chance will only be applicable to those candidates who have completed the Nursing Program / Course (Theory / Practical) in the prescribed maximum time limit (double the duration of the program /course) and the candidate was not able to clear the final year examinations of the respective program / course within the prescribed maximum duration.
 - ii. Maximum number of attempts: 2 (two)
- iii. After qualifying the basic mercy chance examination, the candidate is eligible to appear University examination / Board examination.
- iv. The candidate shall qualify the University / Board Examinations within a period of one year of passing the Mercy Chance Examination.
- v. A candidate shall be granted maximum of two attempts (one regular and one supplementary examination) for University / Board examinations.
- 7. The Mercy Chance Examination guidelines are as per the INC (Notification No.7 of 2022 F.No.1-6/LT/2022-INC, Dt. 28-04-2022 and Notification No.1 of Letter No.F.No.106/LT/INC, dated 19-01-2023 (Notification No.1 of 2023). The details of questions are mentioned in Annexure with this Circular.
- 8. The format of application is enclosed herewith to be filled by the candidate along with all the supporting certificates related to qualification / Nursing course
