ORDER:

In terms of provisions under AP Reorganization Act 2014 in the State of Telangana, the consequential orders have been issued by the Government of Telangana in the reference 1st and 2nd read above. The Telangana Nurses and Midwives Council, (TGNMC) has formed with separate entity. In the reference 3nd read above, the Indian Nursing Council has amended and supersession of certain regulations. Among others, amended certain regulations, namely, (1) Primary Registration, (2) Reciprocal / Transfer of Registration, (3) Periodical Renewal of Registration / Licence, (4) Additional and Higher Qualifications and (5) Penalties. The Indian Nursing Council has revised the fee structure relating to the above items as indicated below: -

A. Fees

- i. Registration fee: Rs. 1000/- for ANM and Rs. 2000/- for GNM/BSc
- ii. Reciprocal Registration fee:- Rs. 1000/-
- iii. Renewal of Registration fee:- Rs. 500/-
- iv. Additional/Higher Qualification Registration fee: Rs. 1000/-

B. Penalties

- i. Delay in Reciprocal of Registration for more than 3 months: Rs. 5000/-
- ii. Delay in Renewal of Registration for more than 6 months: Rs. 5000/-
- 2. Keeping in view the Indian Nursing Council Notification vide reference 3rd read above, the matter has been examined and considered to revise the fee structure in the State. After due consideration of the issue, this Council has decided and hereby ordered to revise the fee structure as detailed in the Annexure appended to this order.
- 3. This revised fee structure shall come to force with effect from 01st October, 2024 positively.
